# FINANCIAL HIGHLIGHTS

The strength of the 2024 campaign was rooted in the diverse ways our community came together to give. Payroll deductions and employee giving through workplace campaigns generated \$89,905, reflecting the ongoing commitment of employees across Williams County who chose to invest in their neighbors through steady and reliable support. These workplace contributions remain a cornerstone of our campaign, demonstrating the power of collective giving. Over 300 employees and 13 local businesses were inspired to give back to their communities. This generosity made up over 50% of the \$250,000 that was raised!

Local businesses also played a vital role in fueling our mission. Together, area companies pledged more than \$80,000, showing that our business community not only drives economic vitality but also stands as a partner in creating positive change. These corporate commitments underscore the importance of collaboration between nonprofits and businesses to ensure a stronger future for all.



In addition, the generosity of individual donors shone brightly this year, with \$60,000 contributed through personal giving. These gifts, whether large or small, highlight the deep sense of compassion and responsibility felt by residents who believe in the mission of United Way of Williams County. Each contribution serves as a testament to the fact that lasting impact is built when individuals come together to support one another.



# PERFORMANCE REVIEW

The 2024 United Way of Williams County campaign was a powerful reflection of our community's generosity and commitment to supporting one another. Together, we raised an impressive \$250,000, ensuring that critical resources continue to reach those who need it most.

Through these funds, 25 local programs and agencies will receive support to provide essential services and life-changing opportunities across Williams County. From **Health** and **Education** to **Financial** needs and community stability, these investment strengthen the foundation of our entire community.



In 2024, we had 85 new donors totaling a donation amount of \$13,454.

#### **COMMUNITY SUPPORT**



Our special events also played a key role in this year's success. The State Bank Gives Truck, Taylor Swift concert ticket fundraiser, and our annual Trivia Night events brought our neighbors together in fun and meaningful ways, raising more than \$20,800 in additional funds to fuel our mission.



Perhaps most inspiring of all, more than 630 individual donors stepped forward to contribute to this campaign. Their generosity, combined with the dedication of our workplace campaigns, corporate partners, and volunteers, demonstrates the incredible impact we can achieve when we come together as one community.

#### THE ABILITY CENTER


Last May, after visiting her doctor, Sally was diagnosed with several disabilities related to her spine. As her pain increased, she began calling around to have a ramp installed at her home to help reduce her need to use stairs.

Shortly after beginning her search, she connected with Becky, our Independent Living Manager at the Bryan office. Just one week later, with funding assistance from the **United Way of Williams County** Grant, The Ability Center's home accessibility crew began the installation.

Sally shared, "I was kind of homebound before the ramp, so I am just so grateful to have more independence. I'm very thankful for The Ability Center! Two of my neighbors have reached out, and I've been so excited to tell them about this organization."



# UNITED WAY GIVES BACK



### THE UNITED WAY WILL DISTRIBUTE 60% TO BACK A RANGE OF COMMUNITY INITIATIVES.

In Fiscal Year 2025 (April 1, 2025 - March 31, 2026), United Way of Williams County will distribute 60% of the \$250,000 raised in FY 2024, These funds will go directly to our local partner agencies and programs, supporting their ability to deliver essential resources to families, children, and individuals across Williams County.

By reducing operating costs, and putting donor dollars to work where they are needed most, United Way of Williams County continues to honor the trust of our supporters and strengthen the safety net that makes our community stronger together.

#### FISCAL YEAR 2025

In April 2025, the United Way of Williams County entered Fiscal Year 2025 with a strong financial plan focused on growth, sustainability, and maximizing community impact. Several key gains stand out as we compare our proposed FY 2025-26 budget with the prior year's performance.

- Reduced Operating Expenses Operating expenses are projected at \$78,710, down significantly from FY 2024 actuals of \$137,800. This reduction ensures that more donor dollars are directed toward community programs and services.
- Positive Net Budget After several challenging years, the FY 2025 budget projects a net positive of \$27,343, strengthening our reserve position and reinforcing United Way's long-term sustainability.
